CAPE BRETON SKI CLUB BYLAWS Election of Officers

SECTION 5. DIRECTORS

- a) The affairs of the Society shall be directed by a board of between five and twenty-five directors who shall be elected at each annual meeting and shall hold office for one year, two years, three years or four years as so elected, or until their successors have been elected. Retiring directors shall be eligible for re-election. the nominations of directors shall be made in such a manner as may be determined by the chairperson.
